## DECISION

The Ministry of Transport of the Czech Republic in its capacity as the Maritime Authority (hereinafter only as the Authority) as the competent administrative authority pursuant to the provisions of Section 3 of Act No. 61/2000 Coll., on Maritime Navigation, as amended (hereinafter only as the "Maritime Navigation Act"), and Act No. 500/2004 Coll., the Administrative Code, as amended (hereinafter only as the "Administrative Procedure Code")

### **decided**

in the matter of the application of the party to the proceedings - the company CIMTO, s.r.o., with the registered address at Líšeňská 2657/33a, Líšeň, 636 00 Brno, Company ID: 04050657, (hereinafter only as "CIMTO") dated 17.01.2023, supplemented on 07.02.2023 by the extension of the authorization Ref. No. 358/2018-130-NPL/1 dated 15.03.2018 for the performance of tests, attestations, assignment of UN codes to packages and inspections according to the International Maritime Organization (IMO) on International Maritime Dangerous Goods Regulation IMDG (hereinafter only as "IMDG Regulation") and further supplemented on 20.02.2023 with the extension of authorization Ref. No. 358/2018-130-NPL/2 of 06.04.2018 for carrying out tests, attestations, assignment of UN codes to packages and inspections according to the IMDG Code

### **as follows:**

Pursuant to Section 3 of the Maritime Navigation Act and Chapter 1.1, sub-paragraph 1.1.1.1.4 of the IMDG Regulation, the Authority authorizes the company CIMTO, s.r.o., with the registered address at Líšeňská 2657/33a, Líšeň, 636 00 Brno, Company ID: 04050657 (hereinafter only as CIMTO) for testing, attesting and checking the functional suitability of packaging devices and packaging units intended for the carriage of dangerous goods by sea in accordance with Chapter 6 of the IMDG Code.

1. Authorization of the company CIMTO is issued in accordance with the submitted Certificate of Accreditation No. 41/2023 dated 01.02.2023, for the period until 01.02.2028 from the date of entry into force of this decision.

2. The CIMTO company will carry out:
  - Conditioning tests for packaging and packaging means according to Sections 6.1; 6.5; 6.6 of the IMDG Code;
  - Drop tests for packaging and packaging means in accordance with Sections 6.1; 6.5; 6.6 of the IMDG Code;
  - Vibration tests for packaging and packaging means in accordance with Section 6.5 of the IMDG Code;
  - Stacking / compression tests for packaging and packaging means in accordance with Sections 6.1; 6.5; 6.6 of the IMDG Code;
  - Leakproofness tests for packaging and packaging means in accordance with Sections 6.1; 6.5 of the IMDG Code;
  - Internal hydraulic pressure tests for packaging and packaging means in accordance with Sections 6.1; 6.5 of the IMDG Code;
  - Tear tests for packaging and packaging means in accordance with Section 6.5 of the IMDG Code;
  - Righting tests for packaging and packaging means in accordance with Section 6.5 of the IMDG Code;
  - Top lift tests for packaging and packaging means in accordance with Sections 6.5; 6.6 of the IMDG Code;
  - Bottom lift tests for packaging and packaging means in accordance with Sections 6.5; 6.6 of the IMDG Code;
  - FIBC tipping tests for packaging and packaging means in accordance with Section 6.5 of the IMDG Code;
3. Inspections and tests shall be carried out in accordance with the relevant provisions of the IMDG Code and the latest version of the UN Manual of Tests and Criteria in force.
4. The CIMTO company shall comply with the accreditation criteria defined in the Certificate of Accreditation No. 41/2023 including the Annex, which is an integral part of the Certificate No. 41/2023 for Testing Laboratory No. 1075 (CIMTO) issued on 01.02.2023 by the Czech Institute for Accreditation, o.p.s., with registered office at Olšanská 54/3, 130 00 Praha 3.
5. The Authority reserves the right to inspect the implementation of the activities in question and compliance with the relevant generally binding legislation and international agreements. In the event of finding serious deficiencies in the activities covered by this authorization, the Authority may require remedial action or, where appropriate, revoke the authorization.

**Justification:**

On the basis of the submitted application and the document Certificate of Accreditation No. 41/2023 dated 01.02.2023, including the annex dated 13.01.2023, which is an integral part of the Certificate No. 41/2023 for Testing Laboratory No. 1075 (the CIMTO company) for testing the functional suitability of packaging and packaging means and packaging units for dangerous goods according to the specified provisions of the IMDG Code, the Authority finds that CIMTO has fulfilled the conditions for testing packaging and packaging means according to the relevant provisions of the IMDG Code as defined in the operative part of this Decision.

For the reasons set out above, the Authority, as the administrative authority, has decided as set out above.

**Advice:**

Pursuant to Section 152(1) of the Administrative Procedure Code, the parties to the proceedings may lodge an appeal against this decision within 15 days from the date of its delivery to the Minister of Transport, via the Water Transport Department of the Ministry of Transport, nábřeží Ludvíka Svobody 12, 110 15 Praha 1.
