RESOLUTION

The **Ministry of Transport**, as the competent authority, has decided pursuant to Section 67(1) of Act No. 500/2004 Coll. of IT, on Administrative Proceedings, as amended, and pursuant to the provisions of Section 1.8.4 of the Regulations for the International Carriage of Dangerous Goods by Rail, promulgated by Communication No. 16/2021 Coll. of IT of the Ministry of Foreign Affairs, amending and supplementing the Communication of the Ministry of Foreign Affairs No. 22/2019 Coll. on the promulgation of a new wording of Appendix C - Regulations for the International Carriage of Dangerous Goods by Rail (RID) of the Convention on the International Carriage by Rail (COTIF), **on the basis of a request from the company CIMTO, s.r.o.**, with registered office at Líšeňská 2657/33a, Líšeň, 633 00 Brno, ID No: 04050657, delivered to the Ministry of Transport on 17.1.2023, registered under the Ref. No. MD-4518/2023-130/2, for the issue of authorization to test, certify and inspect packages, large packages and large IBC containers intended for the transport of dangerous goods in accordance with RID as follows:

Ministry of Transport

authorizes

CIMTO, s.r.o.,

with registered office at Líšeňská 2657/33a, Líšeň, 633 00 Brno, Company ID: 04050657,

to conduct tests, attestations, assign UN codes to packages and inspections according to RID. Specifically then packages - Section 6.1, large containers for bulk materials (IBC) - Section 6.5 and large packages - Section 6.6 intended for transport under RID conditions and subject to the conditions set out in this Decision.

This authorization is issued for a fixed period, until 31st January 2027.

The Ministry of Transport reserves the right to inspect the implementation of the mentioned activities and compliance with relevant generally binding legal regulations and international agreements at any time during the validity of the authorization. In the event that deficiencies are found in the tests covered by this authorization, or in the event of non-compliance with the conditions laid down by the legislation or this Decision, the Ministry of Transport may require remedial action or, where appropriate, revoke the authorization.

Justification:

On 17.1.2023, the Ministry of Transport received from the company CIMTO, s.r.o., with registered office at Líšeňská 2657 / 33a, 633 00 Brno, Company ID: 04050657 (hereinafter only as the "Applicant") application (Ref. No. MD-4518/2023-130/2) for authorization to carry out testing, attestation, assignment of UN packaging codes and inspection according to RID.

The application concerned packages - Section 6.1, large containers for bulk materials (IBC) - Section 6.5 and large packages - Section 6.6 intended for transport under RID conditions. The application refers to the existing authorization of the Ministry of Transport issued to the company CIMTO, s.r.o. on 9th March 2018 (Ref. No. 23/2018-130-OST/1) to carry out tests, attestations, assignment of UN codes to packaging and inspections according to RID (valid until 21.2.2023). The application was accompanied by a copy of the issued Certificate of Accreditation No. 41/2023, which was issued on the basis of meeting the accreditation requirements according to the relevant standards for the activities "Testing of products and packaging system for the transport of dangerous goods as defined in the Appendix to this certificate". The certificate was issued by the National Accreditation Body - Czech Institute for Accreditation on 1.2.2023 with the certificate validity until 1.2.2028.

On the basis of the above facts, the Ministry of Transport has decided, pursuant to Section 67(1) of Act No. 500/2004 Coll., the Administrative Procedure Code, as amended, on the application of the party in the proceeding, who has demonstrated professional competence and compliance with the technical conditions for the performance of the activities referred to in the operative part of this decision.

For the above reasons, the Ministry of Transport decided as set out in the operative part of the opinion.

Advice

An appeal against this decision may be lodged within 15 days from the date of its delivery with the Ministry of Transport via the Department of Rail Transport (Section 152(1) of the Administrative Procedure Code).
